1                   ARTICLES OF INCORPORATION  
2   OF  
3                   ODD FELLOWS SIERRA RECREATION ASSOCIATION.

5   KNOW ALL MEN BY THESE PRESENTS:

6                   That we, the undersigned, all of whom are residents of the State of  
7   California, have this day voluntarily associated ourselves together for the  
8   purpose of forming a non-profit corporation under the laws of the State of  
9   California,

10                   AND WE HEREBY CERTIFY:

11   I

12                   That the name of the corporation shall be, "The Odd Fellows Sierra  
13   Recreation Association."

14   II

15                   That the purposes for which said corporation is formed are:

16                   (a) To organize and administer a Summer Camp for the use of the  
17   members of the Odd Fellows Lodge, to carry on and conduct social, charitable  
18   and betterment activities.

19                   (b) To receive and hold property of all kinds necessary to carry out  
20   the purposes of this corporation.

21                   (c) To convey, exchange, lease, mortgage, encumber, transfer upon  
22   trust or otherwise dispose of all property, real or personal, in connection  
23   with the purposes and objects of this corporation.

24                   (d) To borrow money, contract debts and issue bonds, notes and  
25   debentures and secure the same.

26                   (e) To do all other acts necessary or expedient for the administration  
27   of the affairs and attainment of the purposes of the corporation.

29                   That this is a corporation which does not contemplate the distri-  
30   bution of gains, profits or dividends to the members thereof.
