BOARD OF DIRECTORS MEETING - APRIL 10, 1989

The Board of Directors meeting was called to order at 9:00 AM by President Bob Hintz. All members were present.

MINUTES - Minutes of March 12, 1989 B.O.D. meeting were read and approved.

CARETAKERS REPORT Repaired sun screen at lake. Repaired log and post fence at lake. Cleaned up and opened pine needle burn site. Repaired beach at lake. Water system maintenance. Garbage clean up and cabin patrol. Maintenance and service of equipment.

CORRESPONDENCE: - Letter from Tuolumne Vietnam Veterans #391 asking for design for memorial to Vietnam Veterans. Letter from George Garner resigning from board due to moving from the area, also report for annual meeting on Health and Safety. Change of address for Tommy Keller, referred to bookkeeper.

MEMBERS BEFORE THE BOARD - Mr. Ray Hawkes asking explanation on various items on projected and current costs of running the park. Wayne Harvey expressing interest in running for the B.O.D.

COMMITTEE REPORTS WATER - Pernetti/Johnson - 2,019,700 gallons used. Bacteria reports are all negative. Returned the report to Tuolumne County for fire rating for insurance. ROADS - Bradley - Speed bumps will be installed after Memorial Day. Submitted 10 year forecast for road repair. TIMBER - Smith - Contacted Tim Tate for action on removing bug trees. BUILDINGS - Mitchell - Sunscreens repaired at the lake, also repaired the fence at the lake for summer. HEALTH AND SAFETY - Garner - Some loose dogs were picked up in the park. Members are advised of Tuolumne County leash Law - don't let your animals run loose. RECREATION - Armstrong - Will get donuts for the annual meeting. FINANCE - Zobel - Bills to Recreation Association in the amount of \$3669.23. M.S.C. to pay same. Homeowners bills of \$91.50. M.S.C. to pay. Recreation checking: \$1,735.20. Homeowners checking \$308.50 Timber checking \$1,728.76. Income for March was \$20.00.

OLD BUSINESS - Bradley was instructed to send letters to members who have built walls, etc on park property regarding removal of same. Our attorneys have been contacted. George Garner - asking that a Memorial grove be brought before the annual meeting. Suggesting that the old apple trees be removed and new ones to be planted in memory of members who have passed away. Contacted Amerigas regarding gas cylinders in use by park. Discussion was held on AB1365 (projected costs for running the park for the next five years). This is to give us a budget and assessment projection for this and coming years.

NEW BUSINESS - Discussed painting picnic tables. M/S/C to buy materials to refinish same. M/Mitchell, S/Pernetti to increase the water use agreement cost to \$97,552 for 1989-1990 because of increased costs to the water system. There are five board director seats up for election at the annual meeting. We have three 3-year terms, one 2-year term, one 1-year term to fill. Pernetti and Smith are running again. In order to run for the board you have to be an Odd Fellow or Rebekah in good standing and a property owner in the park. Wayne Harvey has agreed to run; we need at least two more members who are willing to spend the time and energy required. We reviewed many applications for the position of caretaker. Four were selected for interviews.

There being no further business, the meeting was adjourned at 2:10 PM. The next regular meeting will be held May 7, 1989 at 9 AM.

DO NOT put them in the garbage bin!!!!!! If your lot is not cleared of pine needles the forestry will check the park for uncleaned lots and you will pay a fine as this is for fire safety of all who live here.

RABID SKUNKS - Now is the season when skunks are out so beware of rabid ones. There have been reports of rabid skunks in the area (notices in the paper.) Keep your pets well confined or in your control at all times. Rabid skunks do bite other animals.
