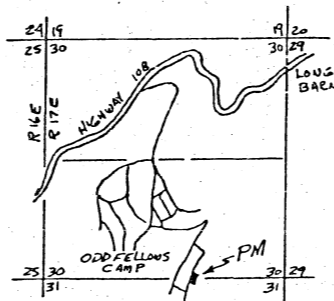


BASIS OF BEARING
