Lodge # 11 secured by a deed of trust on a 50 -50 Basis.

It was Moved seconded and carried that the Odd Fellows Sierra Recreation Association borrow from Charity Lodge And Stockton Lodge #.11 \$16000.00 at 5% interest and not more than 6% per annum

Moved seconded and carried that the finance committe and the executine Meet with the Trustees of Charity and Stockton Lodges to negotiate the terms of the loan, and report backtoo the Directors, and recind the motion of Nov. 5 1957 relating to the matter.

Kerzee, Moak, and Baldwin were appointed on the building committe with Kerzee and Mrs, Ryan on the recreation & playground committe and to present tentative drawings to the Board of Directors at the next meeting on Feby,4th. to be presented to the membership at our annual meeting.
