Baker suggested that Mr Sondgrath, well-knwon road builder for whom he works, would come to the Park and give his opinion on what would be best advice on how we should proceed in method of completiong. No charge for this service. The Board agreed that we should take advantage of his expert opinion.

Water: OK.

Budget: Bogard requested committee chairmen to have their estimates in his hands so his com can prepare the budget in ample time for annual meeting.

Health & Safety - Moody will contact Ellis, who is absent today, for the list of lot owners who must be notified of health and safety violations.

Equipment - Pres asked Baker is he is able to resume chairmanship of that com., and Baker said he would.

Finance - Report for Jan and Feb read and accepted as read.

Communications: Certification of membership forms from Walls, Greenwood and Collins were read. It was M and S that their applications for membership in the Ass'n be approved. Motion carried. Letter read from Burnie Collins stating his lot had been sold to Dorothy Girling, a former member of the Ass'n and from Glen Balcom stating his lot had been sold to James and Loretta Bender. Action on accepting these new owners held over pending receipt of theer membership applications and certification of membership inthe Order. Letter from the Twain Harte Boosters Club asking our organization to participate in their July 4th Carnival. In view of our own program for Land Sales during that week, it was decided to decline.

New Business: Noting the bright sunlight in the Board Room, Margery Lee offered the Board some curtains for the windows. =

Proposed amendments to the By-laws was read by Jack H Hessler, acting representative of a group consisting of 10 member-owners. He was advised of the proceedure required. Margery Lee asked to be eleved of Chairmanship of the By-laws committee due to pressure of work during tax time. Mr Hessler was appointed in her place.

William Kerns, a member-owner who is a real estate professional, was introduced by Moody. He has volunteered his services during our Land Sale Days.

Jack Hessler inquired re the 40' easement for road which adjoins his lot and dead ends there. Land above is not developed. Margery Lee reminded the Board she has a similar situation adjoining her lot and which she also is interested in purchasing. Another Board member recalled that Dan Whybark had also approached the Board regarding the dead end road adjoining his lot. The Real Estate Com will look at each of these parcels and repoart whether they think it would be feasible to abandon any of these portions in order to offer the land for sale to the adjoining lot owners.
