

ODD FELLOWS SIERRA RECREATION ASSOCIATION

September 2- 1956

Meeting called to order at the park at 2.30 P. M. Robt, Nichols presiding. the roll of directors called and absentees noted . those present were Nichols, Hosmer, Buck, Gibson and Rhien. Absent were Escobar, Hodgson, and Bianchi, and Boydston. The minuits of August 13-1956 were read and approved as read. Mesdames Overland and Zimmerman, ( who recently bought the property near Long Barn) were present at the meeting and asked the board of directors if they would furnish them with water to their property. Discussing the matter it was found that it would entail quite a bit of expense to them in the way of a pipe line from the closest point of available water supply and also that they would have to install a pump to get water to their premices as there was insufficient head to get water there by gravity. Jabes Gibson stated that he personally would not supply them with water unless our attorney was consulted on the matter, stating for his reason that we had a lot of extra expense in supplying water to property owners on the Hi-way from Sylvan Lodge north and some property owners across the Yi-Way. The matter was left open. Communications- A letter was read from the State Franchise Board, stating that the association would have to pay franchise tax, as the form sent out was received to late to relinquish the tax and that a bill would be sent later. (The form was sent in by Brother Neil) The secretary was ordered to send the letter to our attorney for disposal. The following bills were read and ordered paid. Oakland lodge Semi- Annual payment 900.00, Interest on notes held by members 256.70 Mary Orr Redemption of note 2,000.00 Gene Bianchi, Bill held over 102.68, Beerman & Jones, Road mix 33.75 R.C. Rhien Services as Sec. Treas. 75.00 Telephone calls 1.53 Sierra Materials concrete pipe 2.50 P.G.&E Electric Service 14.65 Arthur Garrett Services fo August 240.00 Hales & Symon For Corrugate pipe for bridge construction 330.93 Total 3957.34. Beerman & Jones For road work 6181. 43. Grand total 10,138.77. The matter on the exchange of lots by Herb Kearns( which was laid over from last meeting) Was brought up and it was moved seconded and carried that Herb Kearns be given lot 71 in block 21 in exchange for Lot 45 in Block 26. The secretary was instructed to send a bill to O.H. Davis for 18.00 for tractor work done in conjunction with his lot also to send a receipt to M. Angrave for check received for work in conjunction with his lot. There was some discussion on the spring located near the property owned by the Girl Scouts which had to be put in shape By October 1956 and the Board members were to look the project over after the meeting. Loren Hosmer stated that Bro .Cakebread spoke to him about the old timber lying around our property stating that he thought that some paper Co. might be interested in purchasing it and that Cakebread was to contact them and see what goes. Bro. Taylor was to be notified that he forfeited all rights in any lots he might have made a payment on in the subdivision in our park. No further business Appearing the meeting was closed.
