The Board of Directors meeting was called to order by President Bert Johnson. All members were present except Armstrong. Excused.

MINUTES - Board of Directors meeting - Dec. 8, 1985-read & approved.

CARETAKER'S REPORT - General maintenance on water system, repaired equipment, cleanup, etc.

COMMUNICATIONS - Hank & Betty Young - Changed address. Referred to bookkeeper for action. Bill Remington - Change of ownership. Referred to bookkeeper for action. Dorothy & Vincent Ellis - Happy Holidays Greetings. No action required. State of Calif.- Employment Development Dept. - Notice of State Disability claim filed for Tom Jones. Referred to Secretary for action.

COMMITTEE REPORTS:

WATER - Johnson - Water usage for the month was 735,600 gal. Water tests were taken this past month and all tests were good.

HEALTH & SAFETY - Akers - Review of individual garbage use was discussed.

RECREATION - Goff - The Christmas Dinner had 67 people attend. The next potluck will be on Jan. 11, 1986.

CORPORATE RESTRUCTURING - Wallis - The representative from the Grand Lodge is in the process of replying to our questions. We hope to have an answer in February.

FINANCE - Cole - Motion by Cole, sec. by Mitchell to pay bills amounting to \$3,975.75. Passed. Income for the month was \$91.77. Outstanding 1985/1986 dues amounts to \$2,287.85. Small claims action is pending on 9 members. Court proceedings are scheduled for Jan. The B.O.D. consolidated 2 timber fund lockup accounts into one lock up account and one money market account..

OLD BUSINESS - The caretaker is in the process of communicating with the proper authorities to determine what can be done to patrol the park, etc. A report is due in Feb.

NEW BUSINESS - The caretaker has served his probation period..John Henry is now a permanent employee. Motion by Akers, sec. by Mitchell to purchase a telephone. Passed.

The County fire truck is going back because of lack of membership. The Park will be served by the County and State fire vehicles from Long Barn, etc. Our old fire truck is being returned and it will be used as a utility vehicle. The Park is no longer certified as a firefighting unit.

The next regular Board of Directors meeting will be held on Feb. 9, 1986.
