### BOARD OF DIRECTORS MEETING January 17, 2004

President Fred Coleman called the Board of Directors meeting to order at 8:30 a.m.

Invocation by Richard Bonner

By motion (Selman/Smith, unan.) the minutes of December 13, 2003, were approved as mailed.

### Members before the Board: none.

Correspondence: 1. Report on the Audited Financial Statements by E. Clay Maddox, CPA; 2 Letter from the State Board of Equalization concerning water rights fees; 3 Postcard from the California Regional Water Quality Control Board with the web site on which to check the list of dischargers of MTBE; 4 Letter from American Tree Farm System congratulating the Park on its tree certification; 5 Thank you from the Calif. Rural Water Assoc. for answering a water survey; 5 Letter from the Dept. of Health Systems stating that we do not have a licensed water distribution operator and have until December 30, 2004 to get someone licensed; 6 Newsletter from the State Compensation Insurance Fund. 7 Two Grant deeds: From Roy and Natalie Frisk to E. Lynn & Connie Yturiaga, and From Philip and Susan Sugerman to James and Lois Schulke.

### **COMMITTEE REPORTS**

Water – Selman: A total of 972,900 gallons of water were used during the past month. We had a contaminated water sample. The location was resampled and came back clean. P.G. & E. will not consider engineering to move poles without an advance \$1,500 deposit. Neil will get bids from a private contractor after the snow is gone. He is also looking into cost of a used diesel generator on a trailer. It would be for the pumps to keep the water tanks filled in case of an extended power outage.

Finance – Bonner: Bills for the month were \$20,841.63, including \$5000 for the audit. By motion (Smith/Selman, unan.) bills were approved for payment.

Buildings - Smith: The work on the office is almost finished. Ed will make a survey of work to be done on Park buildings.

**Roads** – Coleman: Someone with Blue Pine Construction lost control of a backhoe and tore up part of Deborah. A bid to repair is \$1400. The company will be billed for the damages.

Timber – Coleman: He will talk to Will Dorrell, the Park's Forester, regarding burning slash from the last timber work.

Health & Safety – Kasper: The toboggan hill is solid ice and dangerous. People need to be careful driving or walking behind park equipment. Be sure driver knows you are there and they will let you by. Don't push the snow from your property out on the

Equipment - Coleman; Maintenance work has been done on the snowplow.

**Recreation** – Townsend; We received \$100 from the Lodge for the fishing derby, and \$434 was collected from the raffles at the Holiday dinner. The St. Patrick's dinner will be on March 20<sup>th</sup>.

**Old Business:** The Park's insurance company is going to hire Roger Brown, who is the Park's attorney, to represent the company in court concerning the Boy Scout Camp.

Mike Van Gundy talked to the main helicopter pilot at Columbia about using water in our lake for fire fighting purposes. He was unable to get information we needed regarding a grant to help dredge the lake.

There is a problem with a new driveway being put in near Ruth and Rebekah. The caretakers are to look into the construction plans to avoid danger of water running across the road and creating a dangerous ice situation.

By motion (Kasper/Selman, unan.) it was agreed to contract to have a tub grinder brought in to grind needles this summer. The ground up materials will be sold. Dumping schedules and dates will be made and residents notified. This method of disposal will avoid smoke and allow more time and a more specific date to complete cleaning of lots and property. Grinding of the needles will be co-ordinated with other communities in the area to save expenses.

New Business: There was a pickup parked on Wheeler Rd. during heavy snow and left for a couple of days. A tow truck was called to remove it but the owner came in at that time to get it. They were charged with a tow truck call out. Caretakers have been plowing snow and taking care of fallen trees. There have been complaints of how the snow equipment is being used. Ed Smith said his grandson, Matt, would be willing to come in and train our caretakers on the operation of the road grader. Two park residents are qualified to drive the snowplow and could be hired on a part-time basis to help cut overtime expense. This will be considered.

Fred shared some examples of "Stupid" defined that has occurred in the Park recently. 1. Someone who lies down in the road when the snow plow is coming through -- twice. 2. The resident who threatened violence to employees because he didn't get the road plowed when he thought it should be. (There had been a pickup left in the road when the owner couldn't get up the hill) 3. People allowing children to slide down and across roads when snowplowing is in progress. 4. The group (from out of the park) that blocked Wheeler Rd. at Hwy. 108 and was sliding down Wheeler. 5. Snowboarders and sledders on roads.

Remember that the snowplow can not stop quickly and neither can cars.

There being no further business, the meeting adjourned at 10:10 a.m. The next meeting will be on February 21, 2004, at 8:30 a.m.
