No vote necessary, it restates a prior decision. Bert Johnson will implement the decision. Water: Bell - Liquid level equipment being installed by contractor. Water distribution maps progressing. Equipment: Gibson - General maintenance being performed. The Hough Loader has an offer of \$2,200.00. Moved by Gibson, Sec. by Cole to sell the loader. Passed 8-0. Recreation: (Social) - Harmer - Request rental of hall on Dec. 9, 10 & 11 by Holy Joe's Youth Group and Boy Scouts Troop 363 requested use of hall on Feb. 11 & 12. Both requests were accompanied with appropriate fees. Moved by Wallis, Sec. by Cola to accept requests. Passed 8-0. Recreation: (Planning) - Stephenson - Recreation committee proposed half fish derby expenses to be assumed by the Park. Moved by Dean that future fish derby expenses be included in the Parks Recreation budget. Motion withdrawn by Dean.
