

#### **High Speed Internet Project**

A group is forming to share the cost and effort to bring a T1 Internet circuit (1.544 Mb) to Sierra Park and assemble a radio based distribution network. The first phase is looking for 15 to 20 participants. A second phase will incorporate a bonded T1 Internet circuit comprised of two T1s bonded to form one Internet circuit (3.088 Mb), and allow up to 50 participants. The buy-in cost is expected to be near \$500.00 per participant with a \$30.00 to \$45.00 monthly fee. #### Board of Directors Meeting Minutes February 17, 2007

The Board of Directors meeting was called to order at 8:29 A.M. by President Charles Varvayanis. The invocation was offered by Clark Kellogg. Those present were President Charles Varvayanis, Vice President Mike Ford, Secretary Mike Rainwater, Treasurer Doris Selman, Members, Steve Wallace, Clark Kellogg, and Tom Clark. Absent was Alan Orth, excused.

**Members before the board:** Sue Collie and Robert Cloak. Mr. Cloak reported that during the Boy Scout hearing that all testimony made in court indicated that the Sugar Pine/Long Barn Road was not abandoned by the Boy Scouts because it was never filed with the county.

Executive Session: Board entered into Executive session at 8:31 A.M. and closed the session at 8:33 A.M.

During general meeting, it was announced that Sue Collie would fill Dan Meade's seat on the Board.

**Minutes:** Motion by Kellogg and seconded by Selman to approve the minutes of the January meeting as revised. Revision was a change in words regarding the "volunteer homeowners" by deleted. Motion passed with one vote abstains. A second motion by Kellogg and seconded by Selman to approve the edited minutes for the newsletter. Motion passed with one vote abstains.

**Correspondence:** 1) Telephone call from Fred Coleman concerning Christmas ornaments stolen, 2) e-mail from Pat Cowles reports a fire was set at the side of their house, 3) e-mail from Bob & Georgia Henry reporting an attempted break in, 4) e-mail from Pat Monahan regarding Sierra Park land is not accessible by OFSRA roads, 5) information from Calif. Tree Farm report, 6) letter from Dept. of Health Services, 7) material from Calif. Rural Water Assoc., 8) letter from Edwards & Assoc. re: playground equipment, 9) letter from Zenith Insurance, 10) Registration from Dept. of Motor Vehicles, 11) letter from Caldwell Insurance, and 12) documents regarding the Cedarbrook land.

**Water – Rainwater:** Water usage was 314,000 gals. Discussion concerning water breaks on homeowner's properties, water box markings, tank inspection, and a schedule of recommended water improvements.

Roads - Wallace: Discussion concerning 2007 road maintenance.

**Buildings – Kellogg:** Discussion concerning a light be installed at the dumpster, the wall at the lodge next to playground needs repair, sand shed needs some repair.

**Timber – Ford:** Will contact Will Dorrell regarding timber status.

**Recreation – Clark:** Tom has applied for the permit for the fishing derby and is looking for assistance to help with fishing derby. St. Patrick's dinner is all planned.

**Health & Safety – Varvayanis:** No business.

**Equipment – Orth:** No business.

**Finance – Selman:** Motion by T. Clark and seconded by Wallace to pay the bills as presented. Motion passed with one vote abstains.

**Old Business:** 1) Access to some of OFSRA land is via the Long Barn-Sugar Pine Road. Use of this road beyond the gate at Camp Cedarbrook is necessary. 2) discussion concerning the material received from the Cedarbrook owners regarding the Sugar Pine-Long Barn Road is incorrect and needs to be addressed, 3) pine needle plan was discussed with additional research to be done by contacting Grover landscaping in Modesto.

**New Business:** 1) Discussion concerning the excess amount of mud being deposited on Jordan Way West from the use of the lower road to Camp Cedarbrook.

**Other Business:** 1) Tom Clark will get with Mike Caropreso and check on the willow trees in the meadow, the isolated ones, 2) information was provided by Sue Collie regarding regulations about shooting and proper use of crossing streams, 3) a motion by Selman and seconded by Ford to rescind the fine that was passed at the January meeting re: the water line breakage and usage of water. Motion was passed.

Next meeting is on March 17<sup>th</sup>, 2007 at 8:30 A.M.

Being no further business, the meeting adjourned at 2:45 P.M.
