Dear Homeowners,

It has been a busy time for the caretaker. From Thursday, February 17, to Saturday morning the 19th, the park had over three feet of snow. The caretaker was able to keep the roads open until Friday evening. To avoid hitting a van that was parked across the road, the snowplow slid into the ditch. A tow truck was required to pull out the snowplow. Due to the heavy demand for tow trucks in the county, it was twelve hours before one arrived. During that time, the snow was falling heavily. It was necessary to call for help to clear the roads at considerable expense to the park. The expense to the park because of this situation was a total of \$751.25 which included towing, overtime, outside contractor, and grader operator. By Sunday morning, the roads were all open and widened and the sun was shining. Thanks, Mark for a job well done.

AGAIN, I cannot over emphasize the importance of NOT parking in the roadway during snow removal. It takes time to call and to wait for towing to remove the illegally parked vehicles. This valuable time is needed for snow removal. Please, avoid a towing charge and help the park by parking in the parking lot unless you have off road parking. The park owns a minimum of 10 feet on each side of the road. This space is used for piling the snow.

Some information has been circulating regarding the actions of the current Board members. This information is being circulated by one of our own Board members.

I find the language of the letter confusing and misleading.

The posting of communications between board members to the web is a concern. I ask you to read these with care. ODD FELLOWS SIERRA RECREATION ASSOCIATION BOARD OF DIRECTORS REGULAR MONTHLY MEETING FEBRUARY 19, 2011

INTERIM MINUTES

The meeting was called to order at 2:00 P.M. by President Harvey. Board members present: Emery, Barrett, Harvey, Peter, Hawke, Rainwater, and Varvayanis. Excused absent: Fialho and Velayas.

INVOCATION: Given by Ron Hawke

HOMEOWNERS & OTHERS PRESENT: Homeowners, Mike VanGundy, Steve Wallace, and Carmi & Matt Ennis CORRESPONDENCE : President Harvey reported receiving correspondence from: Maynard Wallin regarding damage to his wall during snow removal in November; an e-mail from homeowner Varvayanis requesting a refund of assessments paid on lots merged at the county in 2004 and 2007 (3 lots into 1); an e-mail from Varvayanis requesting that the refund on assessments be applied to as a credit to future assessments; an e-mail from Varvayanis stating other property owners who have over paid for assessments and that OFSRA needs to pay an assessment for the caretaker's cabin; a letter from Craig Pedro, County Administrator, regarding a meeting was held for Feb. 15th at the Sierra Bible Church, to review the Fire and First Responder plan for the County of Tuolumne. All agencies with fire protection were invited and homeowners who are affected by the services were to attend. President Harvey did attend; an information item, last month insurance people were in MiWuk to assess the I.S.O. (it has to do with rates charged in the area). Linda Clark who works at the MiWuk Fire Statation said they might be coming to our area soon or the results may affect rates in our area; an e-mail from Director Velyas in response to questions asked about financial statements; and a letter from Director Velyas concerning Director Varvayanis' behavior.

MINUTES OF BOARD MEETING of January 15, 2011: Director Hawks moved that the minutes be accepted as presented, Peter seconded, motion carried.

DIRECTOR REPORTS:

WATER - HAWKE : Remember, homeowners are strongly encouraged to turn off their water supply valve and drain their cabins whenever they are going to be away during the cold winter!

A water level monitoring system has been fabricated and installed on two of the Park's storage tanks. The Park has long needed to be able to determine the stored water level without driving to the tanks, which is sometimes impossible. The options considered included: 1) a video camera monitor so as to observe the mechanical level indicator, 2) an ultrasonic depth gauge, 3) an array of float switches installed in the tanks and 4) pressure transducers to monitor the water pressure at the base of the tanks. It was decided the 4th option was the best combination of cost effectiveness, least intrusiveness, and is the easiest to fabricate and install. Two pressure transducers were purchased and installed on the tanks at the Wheeler tank farm, one at the base of the large tank and one at the base of one of the 4 auxiliary tanks. An existing cable that runs underground from the tank farm to an outlet at the end of Joseph Dr. is used to supple the low voltage to power the transducers and read out the gauge voltages, which provides the measurement of the water level heights. The system is working well. The time needed for the Caretaker to measure the system water level has been reduced from about half hour to 10 or 15 minutes and made it possible to monitor when access to the tanks is impractical.

The State is still working on their report on our water system and reissuing of our license.

Investigation of repairs and refurbishment of the problems the divers found in our water tanks last July is underway. So far, the pipes in the well houses have not dropped below 340 F and 420 F on wells 5 and 6 respectively, even while the interior of the well houses has dropped to 310 F.

There were no water leaks this month.

Director Hawke also reported that there is a training class for the water license is scheduled for March 7th & 8th at a cost of \$200 in Tracy, CA. Emery made a motion that the Board spend the \$200 for Mark, caretaker, to attend the class; Hawke seconded, motion carried.

Water usage for the month of Jan. 2011 was 384,000 gallons.

ROADS - EMERY : There are no new updates or information at this time.

BUILDINGS - BARRETT : Update on the new fireplace in the caretaker's cabin; working extremely well.

EQUIPMENT – PETER : All the equipment is holding up well with no problems.

TIMBER - VARVAYANIS : Contacted Will Dorrell, park's timber consultant, regarding the possibility of timbering this year. The mill in Sonora is due to open in May and there is a second market, overseas, that might need our timber. Mr. Dorrell will get back with us in the future. A tree located at 25483 Rebekah, appears that it might need to be removed.

Varvayanis asked that other Board members take a look at this tree and provide additional insight. At this time, no one is sure if the tree is located on a homeowner's property or Park property.

GATE - VARVAYANIS: The new magnets to the gate have been installed at a cost of \$1,725.00. The old magnets were disposed of by Varvayanis as scrap metal and sold to a scrap dealer. A computer has been installed in the gate house that will enable Directors/caretaker to search the video files quickly in order to view problems that have occurred at the gate in the past. A new surge protector battery was installed. There was money collected for gate openers totaling \$290.00.

FINANCE – VELAYAS : (EMERY) Due to Velayas being absent, Emery presented the bills for payment which were: \$16,962.40. Hawke moved to approve payment, Barrett seconded. Motion carried. The repayment of reserve funds and loan to the specific funds will be paid at the end of the fiscal year as it has always been done in past years.

COMMITTEE REPORTS :

WATER LICENSE – VARVAYANIS: Varvayanis reported that the Park's attorney addressed the questions asked by the Board at last month's meting regarding the new Water Use Agreement and License Agreement. The committee then made slight changes to the verbiage and finalized the two documents. Those documents will be presented at the annual meeting, May 2011. President Harvey thanked the committee for their hard work. A new committee was created regarding the Rules/Regulations document which is connected to the Water Use and License Agreement documents. That committee will consist of Hawke, Rainwater, and two homeowners from the Park.

UNFINISHED BUSINESS:

- 1. **RAFT EMERY** reported that the cost to install a new raft at the lake would be \$2,000. The cost would include new floatation material, trex boards, and safety ladder. This item and the cost will be presented to the general membership at the annual meeting in May.
- 2. LIGHTS PRESIDENT HARVEY recommends that the lights at the garbage, garage (behind the lodge building) and fire station be left on all night. (This is currently being done) The light at the lake is property of PGE and they charge the Park a minimal amount each month for that light and its maintenance. President Harvey will seek bids for the installation of an additional 20 amp line to the lodge kitchen. The light fixture behind the lodge building will be changed to a motion sensor.
- 3. Internet Connection Varvayanis asked why the Board decided to use dial-up versus a high speed connection concerning the corporation's computer? The board explained to Varvayanis that it was taking to long for the installation and the installation was becoming complicated. Varvayanis also expressed his concern that his actions when dealing with Sierra Communications was in the best interest of the Park. The Board responded that they felt that there was a conflict of interest between Sierra Communications and Varvayanis' personal business.

4. NEW BUSINESS:

- 1. Acceptance of the resignation of Director Nelson. With great regret, Peter moved to accept, Barrett seconded. Motion carried.
- 2. On February 2, 2011, response by e-mail of six positive votes supported the appointment of Mike Rainwater to fill the vacancy of Secretary for the remainder of the year.
- 3. Appoint Director for recreation director, no one volunteered. President Harvey will check with other people.
- 4. **Request** for refund of assessments, this issue will be discussed as old business next month.
- 5. Issuing stock certificates to OFSRA members. Hawke moved to issue stocks, Varvayanis seconded. Motion carried. Rainwater indicated that he would like to complete this task and is asking all Odd Fellows and Rebekahs that have not been issued certificates to contact him. The number is 209–586–2792. Verification of OFSRA membership and owned property in Park for 5 years.
- 6. Budget review forms were provided by Velayas via e-mail for next month's meeting.
- 7. Apple orchard pruning bids have been received. Joe Cover's cost was \$1500.00 and Gordon Rosefield cost was \$850.00. The job included the 23 trees being topped, thinned, shaped, remove dead, and a follow up in the Spring. Motion by Hawke to accept Rosefield's bid, Barrett second. Motion denied due to budget constraints at this time. This matter will be passed onto the next Board.
- 8. Move paper boxes to a new location. The present location is unsafe for both the delivery person and Park residents who pick up their papers. Discussion between Board members as where to place the paper boxes and keep them easily accessible. After some discussion, further review for new location will be conducted by all Board members.
