CORRESPONDENCE: California water labs. - Bacteriological test for drinking water results. Sample met current state health bacteriological standards for coliform bacteria. No action is required.

Motion by Cole, sec. by Smith to turn down the request because of prior policy, insurance, etc. considerations. Passed

WATER - Johnson - The new pump is in the Kern Creek well. Water usage for the month was 1,247,600 gallons.

ROADS - Hintz - No report.

BUILDING - Mitchell - No report.

HEALTH AND SAFETY - Smith - Handrails have been installed on the foot bridges.

RECREATION - Garner - Two requests were made by park members to use the hall June 4 and June 25. Motion by Wallis, sec. by Smith to approve the requests when deposits, etc. are received. Passed.
