BOARD OF DIRECTORS MEETING - MARCH 15, 1992

The Board of Directors meeting was called to order at 9:00 AM by President Ed. Smith. All members present except Ferneti, Cloak, Clifton, excused.

MINUTES-Minutes of February 9, 1992 B.O.D. meeting were read and approved as read.

CARETAKERS REPORT - Gates have been installed on Sugar Pine Road on both ends of the Park. Repaired drain gates for lake.

CORRESPONDENCE - 1. Letter from Doug Kelly Re: addition to be built on his cabin. 2. Letter from Mr. Wiley re: proposed subdivision of the 5 acre parcel on Jordan Way..

MEMBERS BEFORE THE BOARD -1. Mr. & Mrs. Valentine -observers

COMMITTEE REPORTS WATER -Smith-Ferneti-Water use: 378,000 gals.

ROADS - Mitchell - No activity.

BUILDINGS - Mitchell - There is a new leak in the Rec Hall roof. Will try to locate and patch.

TIMBER -Adams - Forester will be contacted re: timber plans for 1992.

HEALTH AND SAFETY -Clifton - BB guns have been used to shoot out windows on East Jordan. No shooting of any kind allowed in the Park. No sledding on roads or other people's private property. Lots of garbage is being left around the snow play area. Please clean up your cans and papers when using the area.

EQUIPMENT -Harvey - All equipment is in good shape. When the weather gets better a car port will be built for the loader.

RECREATION - Greene - The St. Patrick's Day Corned beef & Cabbage Dinner was a success. This will be an annual event with the Park providing the Corned Beef. The Fishing Derby will be June 20, 1992 at 8:00 AM. The spaghetti feed will be May 23 at 6:30 PM.

FINANCE -Zobel -Bills for Homeowners Association: \$87.50. Bills for Recreation Association: \$4,990.15. Bills for Timber checking \$1,090.00. MSC to pay the bills.

OLD BUSINESS -There was discussion re: garbage changes. The bin will be picked up once a month. EPA will have to approve our burn area this year. NOTHING can be dumped and burned except natural forest items. Dump will be open week-ends only April, May, June, 8 AM to 4 PM. Dumping of anything other than pine needles and limbs will cause the dump to be closed.

OLD BUSINESS - There will be three openings on the Board of Directors this year. Anyone interested in running should send a note to the Board at P.O. Box 116, Long Barn, CA 95335. An attempt will be made to start a neighborhood watch program in the park. More information later. New fruit trees are to be planted in the orchard. Any one wishing to donate \$5.00 to buy a tree can contact the caretaker.

There being no further business, the meeting was adjourned at 10:40 AM. The next regular meeting will be held April 12, 1992 at 9:00 AM.
