Board of Directors Meeting, Minutes, March 11, 2001

The Board of Directors meeting was called to order at 8:30 a.m. by President Del Wallis. Present were President Del Wallis, Vice President Robert Snell, Secretary Norrine Coyle, Treasurer Richard Bonner, Members Greg Brown, Deena Hague, and Ed Smith. Absent and excused was Raul Morales.

The invocation was given by Richard Bonner.

The February meeting was canceled because of the heavy snow fall and relative activities. The bills were reviewed by a finance committee and approved for payment and will be presented for approval by the full Board.

Minutes - By motion (Smith/Bonner, unan.) the minutes of the January 14, 2001, meeting were approved as mailed.

Correspondence received - Henry Overacker presented two bids to repair his vehicle which was damaged by the gate; (This claim has been denied at a previous meeting so no action was necessary.) a note from a property owner about dog owners not cleaning up after taking their dogs out "for a nature relief walk;" two letters from the Park's insurance carrier--one with the bill for the insurance premium for the coming year, and the other concerning inspection of playground equipment and covering instrument panels of equipment that is not in use; a check from a property owner which is to be applied toward her assessment for next year; a letter from Everett Akers informing the Board that, due to poor health, he'd had to sell his home in the park; a letter from the State of Calif. Controller regarding unclaimed property that is to be sent to the State; two letters from the State Dept. Of Health Services concerning water systems and certification.

Committee Reports:

Water - Morales: Randy reported that water usage during February was 414,700 gallons, and in March was 614,000 gallons.

Roads - Snell: There is about a 30% increase in prices which means we will not be able to do as much road work next year.

Building - Smith: New recreation hall supplies have been delivered.

Timber - Coleman: Nothing to report this moth.

Health & Safety - Hague: Cars parked on or near the edge of the roads have caused a problem when the caretakers are plowing snow. If the snowplow can't get through, the road will not be plowed. The note from the property owner concerning people leaving "Doggy Doo" on other people's property was discussed.

Equipment - Brown: New chains have been put on the snow plow, a new ignition installed, and the old alternator will be rebuilt.

Recreation - Snell/Coyle: The St. Patrick's Day dinner is planned for March 17.

Finance - Bonner: Bills for February were \$11,884.18 and timber expenses were \$11,836.18. By motion (Smith/Coleman, unan.) the February bills were approved. The March bills amounted to \$11,685.33. By motion (Hague/Coleman, unan.) the March bills were approved.

Old Business - The President and the Treasurer talked to the CPA about how to handle the new minimum wage laws. It was decided that both caretakers would be considered management. Therefore, the caretaker's cabin must be rented. By motion (Hague/Smith, unan.) the rent was set at \$575 per month for the next two years or for as long as the present Assistant Caretaker works for the park.

New Business - Ed Smith reported that he had received a call regarding rental of the park for an area-wide Odd Fellows and Rebekahs picnic in July. Bill Williams was present at the meeting concerning this item. We need to know how many people might attend. The person who is organizing the function will be informed about the costs and insurance requirements.

The caretaker has moved out of the Boy Scout camp. The gate into the camp needs to be closed and locked.

There was a discussion about the Park's insurance.

The meeting adjourned at 10:00 a.m. The next meeting will be on April 15, 2001, at 8:30 a.m.
