The Board of Directors meeting was called to order by Vice President Robert Snell at 8:30 a.m.

Invocation by Richard Bonner

By motion (Brown / Smith unan.) the minutes of February 21, 2004, were approved as mailed.

Members before the Board: none.

Correspondence: 1. A form from Cindy Billiam of House Mart asking for information about the Park on behalf of some property owners. 2. Letter from Rich and Lisa Van Rosendale informing the Board that they are selling their property to Tony and Salina Pimentel. 3. A letter from Robert and Donna Raymond who are new property owners requesting information about the Park: 4. A letter from the State Dept. of Health Services regarding the availability of a report on the Drinking Water Revolving Fund: 5. A report from the County of Tuolumne regarding crops for 2003; 6. A newsletter from the State Workers Compensation Fund.

### **COMMITTEE REPORTS**

Water – Selman: Water usage was 712,000 gallons for the past 28 day period. Gary Scarborough is going to Sacramento Monday for a test review to prepare for taking the water distributor test. Neil has been unable to make contact with Barry Electric for information about a generator and for some work on two well houses.

Roads – Snell: He is about ready to start evaluating the roads in the park to determine what needs to be done, and how much and what kind of construction we can afford to do. There is some road failure near the Caretaker's cabin and other locations. The problems appear to be caused by the cold weather, water and tree roots.

Buildings - Smith: There is one more window to install in the lodge building.

Timber - Coleman: excused, no report.

Health & Safety – Kasper: Richard Bonner said two Rottweiller dogs have been allowed to run loose in the park and threatened a couple of people. If anyone sees any dogs running loose, call the County Animal Control office immediately.

Equipment – Brown: All is well with the equipment. He has not been able to get information about a blade for the backhoe.

**Recreation** – Townsend: The St. Patrick's dinner will be this evening. The fishing derby for children 15 years of age and under will be on Saturday, June 19. That would be the date for the Board meeting, so it will be changed to Sunday, June 20<sup>th</sup>.

Finance – Bonner: Bills for the month were \$10,925.92, By motion (Townsend/Selman, unan.) bills were approved for payment. Saturday, Apr. 3<sup>rd</sup>, at 9 a.m. will be a budget meeting for members of the Board of Directors.

Old Business - none

New Business – It is requested that the Park phone number be placed in the newsletter again. It was reported that Fred Coleman had met with the people in charge of the grinder and details have been worked out.

## <u>REVISED</u> **LOT CLEAN-UP 2004**

#### Members:

Last month I advised you of the procedure for the removal of needles and limbs from your property in the Park. A question came up concerning the use of the burn area. are not planning on using the burn area this year. As a result, if you miss the use of the grinder, you will have to make arrangements to haul the material removed from your property down the hill to a disposal site. This is quite expensive and you would be advised to clean your lot during the scheduled times noted below:

- April 29<sup>th</sup> to May 3<sup>rd</sup>. 1.
- May 13<sup>th</sup> to May 17<sup>th</sup> May 27<sup>th</sup> to May 31<sup>st</sup> May 13<sup>th</sup> 2.
- 3.
- June 3<sup>rd</sup> to June 7<sup>th</sup> 4.

The Park will begin picking up the needles/slash material on Tuesday following each Monday listed above. Thursday pick-up mentioned last month was an error.

After meeting with Jake, the representative of Grover, which is the company doing the grinding, there are some updates on what we can accept in addition to the needles and slash discussed last month. For example:

- 1. We can take stumps
- 2. Trees cut into ten-foot lengths.
- 3. Old firewood you have not used that is rotting away and you want to get rid of.

You or someone hired by you must haul the materials in the list above to the collection area. Arrangements for a time to deliver stumps, trees or firewood must be made with Mike or Gary. All items must be natural material. We will not take boards, plywood, painted material, etc.

So far we have had a great deal of positive response to our plan this year.
