RESERVE SUNDAY MAY 24 TO ATTEND YOUR ANNUAL MEETING HERE AT PARK REC. HALL 9 A.M. - IT IS VERY IMPORTANT TO ATTEND - PROTECT YOUR INTEREST IN THE PARK.

CLEAN THOSE LOTS - The time is now. Do it before the fire season. Come to the Park and rake up those pine needles and slash on your lots and you may haul them to a disposal site in the meadow below the dam in a designated area - - ask the caretaker where. Please, only needles and slash - no trash or garbage or old furniture and such. If you act now you'll save being asked by the U S Forest Service to clean your lot of burnables at least 20 feet around all buildings. Also trim limbs of trees to clear all chimneys by 10 feet. Make sure all chimneys are screened at top. - - Help Smokey hold down fire danger!

MOTOR CYCLES & MOTOR BIKES - Please, if you or your children ride in the Park - Be sure to hold your speed to 10 miles per hour past home areas. - Keep on roads in our subdivided areas and out of meadow and lake area. Also in respect of all don't joy ride before 8 AM or after 11 PM. All bikes must use lights after dark. In final, take heed, the Forest Service checks for spark arresters on your muffler and you must either have a vehicle road license or off road license on your machine.

DON'T BE CAUGHT SLEEPING - Carry those chains. A freak snow storm could catch you even up to May 30th or so. Last year there was a late snow storm on Memorial Day Weekend, remember?

SIERRA PARK ODD FELLOWS LODGE NEWS - Our first Pancake Breakfast of the season will be in the Recreation Hall on Sunday, April 26th, 7 A. to 10 AM - Pancakes - Bacon - Eggs. Everybody come!
