

Odd Fellows Lodge 376	Household Hazardous Waste Disposal	
The Grand Lodge rejected our request to move the lodge meetings to the third Saturday of each month beginning at 7:45 AM just prior to the Board Meetings. They stated that reducing the meeting to 15 minutes would not be possible. As a result the Sierra Park Lodge 376 will close and the charter will be picked up some time in June or July. All members of our lodge will be automatically transferred to the Gene Bianchi Lodge. The Gene Bianchi Lodge is a holding or "virtual" lodge.	Laws adopted since 2000 created California's "Universal Waste Rule". This rule bans the placing the following items in our dumpster: paint, motor oil and filters, antifreeze, consumer electronic devices, video display devices (televisions, computer monitors, and laptops), batteries, fluorescent light tubes, major appliances, mercury switches, and nonempty aerosol cans among others. The "Universal Waste Rule" went into effect on February 9, 2006. Some of these items can be disposed of free of charge at the Cal Sierra Transfer Station, 19309 Industrial Dr, Sonora CA, (209) 536-1719. Hours of Operation: 7 days

#### Board of Directors Meeting Minutes April 21, 2007

The Board of Directors meeting was called to order at 8:30 A.M. by President Charles Varvayanis. The invocation was offered by Al Orth. Those present were President Charles Varvayanis, Vice President Mike Ford, Secretary Mike Rainwater, Treasurer Doris Selman, Members, Alan Orth, Clark Kellogg, Steve Wallace, Sue Collie, and Tom Clark.

Members before the board: Mr. Rex Weichhart observing.

**Minutes:** Minutes of March 17, 2007 meeting: Motion to approve the minutes of the March 17, 2007 meeting was approved as presented for the newsletter.

**Correspondence:** 1) Letter from Marjoree Cox re gate code, 2) Information from Edwards & Assoc. re: wood chips, 3) Dept. of Health Services Conference, 4) material from Calif. Rural Water Assoc., 5) California Tree Farm Conference, 6) Information from Grover Landscaping re: pine needles, 7) ASTM re: wood chip specifications, and 8) Letter from Pete Delaney advising he has certification as a T-2 and D-2.

#### **Committee Reports**

**Water – Rainwater:** Water usage was 447,400 gals. The water line near Camp Cedarbrook was inspected and will need some adjustment later this year. Capital improvements for the water system will be presented under budget items for the 2007/2008 budget items.

**Roads – Wallace:** Repair to the foot bridge on Westside of lake is on hold until the weather gets better. Capital improvement for roads will be presented during budget discussions. The eastside foot bridge to the lake needs repair. Mr. Wallace presented a plan for repairing the foot bridge with steel supports and a wood walk way. The labor for this project will be performed by Park employee and volunteers. Discussion concerning this project by the board centered around which budget fund would pay for this project and other necessary requirements. Discussion was tabled until further information could be obtained. Another project in need of attention from the Board concerns the road bridge on East Jordan Way. After inspecting the underside of the bridge, it was determined that a large amount of rust has built up and needs some preventive maintenance. Motion by Kellogg and seconded by Ford to accept a proposal to repair the bridge and funding of this project to be paid for from the road reserve fund. The proposal calls for the sand blasting, application of epoxy primer, and an application of urethane finish. Motion was passed unanimously.

**Buildings – Kellogg:** Repair to the handrail/short wall at lodge is on hold until weather improves. The sand shed repair will be discussed under the budget items for 2007/2008 budget. Lodge and cooperate building need to be inspected for the possibility of being painted this year.

**Timber – Varvayanis:** Discussion by the Board concerning information from Will Dorrell pertaining to the approximate profit that could result from timber harvest. Will felt that possibly between \$30,000 and \$55,000. Will is presently marking trees for possible harvest in compartments 1, 3, and 5. Questioned asked by Will Dorrell to the Board was whether or not the Board wanted trees marked all the way up to a property owners property line? Motion by Kellogg and seconded by Clark that a policy for OFSRA will be that marking, thinning, and harvesting will be performed up to the property owners property line. Motioned passed with one opposed, Mr. Ford. An additional motion was made by Ford and seconded by Kellogg for a policy to grant the right to a property owner to request the prevention of harvesting of marked trees within 100 feet of the property owners line; provided that: 1) property owner maintains the 100 feet past his property line in a clean and safe manner, and 2) property owner signs a waiver of liability for any damage resulting by the granting of said waiver. Motioned passed unanimously.

**Recreation – Clark:** Tom reported that volunteers are needed for the fishing derby. Sign-ups for the derby will be at 6 A.M. on June 16th at the lake as well as at 5 P.M. till 7 P.M. on Friday the 15th of June at the Lodge. Registration time will be shorten by filling out an entry form from the newsletter and bringing it with you to either Friday night's registration or Saturday morning's registration.

Health & Safety - Varvayanis: No concerns at this time.

#### Equipment - Orth: None.

**Finance – Selman:** Motion by T. Clark and seconded by Orth to pay the bills as presented. There were \$5,461.25 in bills and \$56.95 credit from PGE. Additional income from the month of April was \$284.55. Motioned passed unanimously. There is still one double assessment outstanding. This assessment will be processed through small claims court. Motion by Kellogg and seconded by Wallace to establish a Section 125 plan for OFSRA and not to exceed \$400.00. Motion passed unanimously. Majority of the Parks insurance policies are to be renewed in May at a cost of approximately \$28,288.00.

**Old Business:** 1) The letter from Richard and Irene Barret concerning the replacement of their retaining wall was addressed and the Board agreed that the Barrets need to contact the county for proper permits and location of their property lines. Board agreed that the owners of Cedarbrook Camp will be assessed \$300.00 for the year 2006/2007 for road maintenance. The Park's account will bill the owners. 2) The Board discussed the pine needle removal options and a motion from Collie and seconded by Selman that Cover will handle the pine needle removal this year. The pine needle/old burn area is open from 8 A.M. to 4:30 P.M. daily except for bad weather. 3) Board discussed the 2007/2008 budget and reserve funds. The Board requested changes to the budget and after several hours of discussion completed a proposed 2007/2008 budget. In addition, the general meeting notice, proxy, and budget proposal was reviewed for printing and corrections were made. 4) Information received concerning the playground and the amount of chips needed to insure proper depth was discussed with a motion by Collie and seconded by Ford to update the playground to the safety compliance needed with proper materials. Motioned passed unanimously and Mr. Wallace will call and order the chips as soon as possible.

**New Business:** 1) There will be a bake sale by the Dogwood Rebekah Lodge No. 200 in conjunction with the annual meeting. The June Board meeting will be held on the 23rd of June due to the fishing derby on the 16th.

Other Business: 1) Seventy-seven people are receiving the newsletter via e-mail.

Next meeting is on May 19, 2007 at 8:30 A.M.

Being no further business, the meeting adjourned at 3:30 P.M.
