BOARD OF DIRECTORS MEETING - MAY 8, 1993

The Board of Directors meeting was called to order at 9:00 AM by President Wayne Harvey. All members were present except Keller, Clifton.

MINUTES - The minutes of the 4/10/93 meeting were read and approved.

CARETAKERS REPORT - Homeowners must get a burn permit if you want to burn on our own lot.

CORRESPONDENCE - 1. Letter from the Dietricks concerning this winters snow plowing. 2. Change of ownership of Girling property to son. 3. Change of address for Chuck & Joyce Aston. 4. Change of ownership of Bambauer Estate to Norman & Denise Silva. 5. Letter from Doug Kelly stating that he had paid Stan Robinson to clean three lots but Mr. Robinson never completed the work. 6. Letter from Aqua Lab stating that copper & lead will be monitored in our water system.

MEMBERS BEFORE THE BOARD - None

COMMITTEE REPORTS WATER - Smith-Keller - Water use: 605,000 gals. The new tank is on line. It is a 43,000 gal. tank. Chlorine was used when it was brought on line.

ROADS - Morrison - We are developing a list of homeowners that need to install a culvert under driveways.

BUILDINGS - Tolbert - None.

TIMBER - Adams - Extensive report by Tim Tate (our forester) on possible future plans.

RECREATION - Clifton - There will be a spaghetti dinner on May 29th, 5:00 to 6:30 PM. \$5.00 for adults and \$2.00 for children. The Annual Fishing Derby will be June 19th. Registration will be at 7:00 AM and the Derby will begin at 8:00 AM.

HEALTH AND SAFETY - Greene - The Burn Area is open every day until further notice, but we may have to close it in June. Get your lots cleaned soon.

EQUIPMENT - Cloak - All equipment is in proper operating condition.

FINANCE - Zobel - Bills for Homeowners Association: \$387.80. Bills for Recreation Association: \$9,945.94. Bills for Timber Fund \$0.00. MSC to pay the bills. Balance for Recreation Association checking: \$32,716.63. Balance for Timber Fund \$76,716.63.

Be sure your present address is correct. The Annual Assessment will be sent out shortly after the Annual Meeting and correct addresses are necessary. Members will only receive one bill with no reminders. Unpaid assessments are turned over to Cimarron Collection Agency. Presently there are four liens filed against homeowners from unpaid 1992 assessments.

OLD BUSINESS - Six swing seats will be replaced at a cost of about \$130.00. MSC to approve revised Park Rules and distribute at the annual meeting.

NEW BUSINESS - MSC to authorize Tim Tate to proceed with a 7 year timber proposal as presented to the Board on May 8, 1993.

PLEASE RECYCLE!! - Two green recycle bins have been placed in the dumpster area. One is for aluminum cans and one is for glass. Lids and caps must be removed and the glass rinsed. A person has volunteered to deliver recyclables to the recycle center. NO GARBAGE in these bins, please.

There being no further business, the meeting was adjourned at 12:20 PM. The next regular meeting will be held June 13, 1993 at 9:00AM.
