Make sure a proper mesh screen is installed on chimneys and stove pipes to keep sparks from getting out. Keep all inflamable fluids such as gasoline & keresene in closed metal containers and away from stoves and open flames. We've been advised the Pinecrest Dump will accept lot cleanings through June 27th. After that they must be hauled to Jamestown.
