FIRE DANGER HIGH

The grass in our meadow is eatra high this year and getting dry and the whole woods are getting dry as tinder. Be careful and watch your smoking and outside fires. No burning during the Fire Season. Campfires only with apecial permit from Forest Station at Mi-Wuk. Cut all dry grass and remove all pine needles and burnables within 30' of all buildings, butane tanks and fire wood piles. Be sure all chimneys are screened and all tree boughs are cut at least 10' clear of them. Failure to comply with the above can endanger your property plus cost stiff fines from the U.S. Forest Service. Remember we are in the National Forest and have to abide with its rules.

SAVE ON FUEL - TAKE WALKS OUT OF THE PARK

First take Solomon Rd to end and out logging dirt road to first fork in road, go right up to our new big water tank, past tank on road to next fork, then left on up to top of hill and turn-a-round. From that spot you can walk out to left a few steps and view Wright Creek Falls on opposite side of Tuolumne Canyon. Walk straight ahead to West a few steps and view Bottini Apple Ranch and North Fork of Tuolumne River far below. Looking high and to the Weet you can see way down to the valley toward Modesto in the distant haze. This hilltop is my favorite with good field ghasses. Along the opposite canyon are old mines, flumes, etc.

The Board would like to thank Bert Johnson and Ed Cole for the work they did to repair our lake - THANKS. Bids have been received for removing stumps along the roadway. There were two bids received. Motion by Stephenson, sec. by Wallis to authorize Vince Tree Service (the lowest bid) to remove the stumps - cost not to exceed \$1,000.00. Passed. 8-0. There was only one road contractor willing to bid on road work in the Park. Arrow Striping submitted four separate bids for work to be performed. Johnson recommended the Board adjust their bid specs and have a special Board meeting on Aug. 19 at 9:00 A.M. to let the bid for road work. Water: Bell - General Maintenance being performed.

Equipment: Gibson - General maintenance being performed. Recreation (Social): Harmer - Requests by Roy Eastburn to rent the hall on Sept. 8 and Sonora Lodge No. 1587 B?P?O? Elks to rent the picnic grounds on Aug. 12. The appropriate deposits were forwarded. Motion by Stephenson, sec. by Akers to approve the requests. Passed 8-0. The local Odd Fellow lodge requests the use of the hall for monthly pancake breakfasts. Motion by Wallis, sec. by Gibson to rent the hall to the lodge for \$1.00/mo. Passed 8-0. The annual barbecue will be held Sept. 2 from 3:00 P.M. to 6:00 P.M. Tickets are \$5.00 for adults (steak, beans, corn, salad, bread, punch and waterwelon) and \$1.75 for children 12 and under (hot dog, beans, salad, punch and watermelon). Mildred Moody of the recreation committee reported the recent carnival was very successful. They made approx. \$20.00 and everyone had a good time.
