BOARD OF DIRECTORS MEETING August 12, 2001

The Board of Directors meeting was called to order at 8:30 a.m. by President Del Wallis.

Present were President Del Wallis, Vice President Robert Snell, Secretary Norrine Coyle, Treasurer Richard Bonner, Members: Fred Coleman, Deena Hague, Raul Morales, Ed Smith. Absent and excused: Greg Brown.

The invocation was given by Richard Bonner.

By motion (Snell/Morales, unan.) minutes of the July meeting were approved as mailed.

Members before the Board: Some residents on E. Jordan Way talked about problems with a neighbor's children and their friends riding unlicensed motorcycles and 4-wheel drive vehicles in the meadow, letting their dogs run loose, and a septic tank that is not working properly. The President read a draft of a letter the attorney has prepared to send to the people causing the problems, saying they must obey the State laws as well as the Park rules. By motion (Smith/Morales, unan.) the President is to have the attorney mail the letter. Charles Varvayanis attended the meeting.

Correspondence: A letter from Robert Worthington saying his property has been deeded to his 3 children; grant deeds from Howard & Carolyn Minor to John & Nancy Weitzel, from Palma Kuykendall to Marcia Clockedile, and from Stanton & Julie Perez to Michael Hawthorne; letters from P.G. & E. saying they are separating the caretakers cabin from the commercial part of the Park's electrical bill and providing information about putting time of use meters on wells 5 and 6, which can lower the electrical bill; letter from Randy & Kathy Armstrong regarding remodeling work on their property on Abraham; letter from Bill Hauff and a form from California Reforestation, Inc., concerning removal of some trees to build a garage; letter from the State Department of Health Services regarding the Safe Drinking Water State Revolving Fund; copy of a letter to Will Dorrell, Forester, concerning the recent thinning operation and State reimbursement of \$9,900.00.

Committee Reports:

Timber - Coleman: We have received \$75,000 for timber, with another \$10,000 withheld in case of further costs. The \$75,000 was split between the two funds. Taxes will be paid out of the \$10,000. Will Dorrell presented another check for \$6,923.41.

Water - Morales: Two broken water lines were repaired. Water usage last month was 1.2 million gallons. The caretaker was directed to look into installing chlorinators on two tanks so that the caretakers do not have to climb up on top of the tanks to add chlorine when necessary.

Road - Snell: Road work has been completed except for some patch work.

Health & Safety - Hague: There have been some kids riding motorized scooters and skateboards in the Park. One boy broke his arm while riding skateboard. The rule is if you can't legally ride or drive a vehicle or skateboard on Highway 108, you can't ride them in the Park. There have be some complaints about people shooting paint guns in the park, which is not allowed. There are some septic tank problems, and the County Environmental Health Dept. will be asked to check on them. Since there is no longer any fresh water coming into the lake, the lake will be checked to determine whether it should be closed to prevent illness. After a discussion about someone giving out the 4-digit commercial gate codes to potential property buyers, by motion (Smith/Hague, unan.) changing those codes was approved.

Recreation - Snell/Coyle: No report.

Buildings - Smith: The price for 2 dual pane windows for the hall would be \$1,637.92. It was recommended that the replacement be delayed a year, and the caretaker would be able to do it in sections, rather than two long windows, for a lot less. By motion (Bonner/Morales, unan.) it was agreed to proceed with the small window in the Board room for \$399.47.

Equipment - Brown: The convault tank needs to be serviced to prevent leaks, and a new pump is needed. By motion (Morales/Coleman, unan.) the caretaker was directed to get the pump and whatever service is needed.

Finance - Bonner: Last month's bills came to \$13,987.66. By motion (Coleman/Hague, unan.) the bills were approved for payment. The Treasurer said he'd moved \$7,200 from the Reserve into the Water Reserve, \$22,400 from the Road Reserve to pay George Reed, and \$18,900 from the Timber Fund to pay for chipping and pay California Reforestation, Inc. There are still 27 assessments outstanding, one of which is in escrow. Late notices have been mailed. If they are not paid by September 1, legal action will be started to collect them.

Old Business: By motion (Bonner/Morales, unan.) time of use meters are to be purchased for wells 5 and 6.

New Business: The President reported that the Fire Department had asked about setting down a medi-vac helicopter in the meadow if necessary. It was felt that this would be appropriate if someone in the park needed it. The Park Manager's report is attached to the original minutes.

There being no further business, the meeting adjourned at 10:10 a.m. The next meeting will be on September 9, 2001, at 8:30 a.m.
