If you have not had the opportunity, please come down and take a look at our world class horseshoe pit. It might be fun to have a horseshoe tournament on Sunday of the Labor Day weekend during the picnic. The picnic begins at 11:00 A.M. Remember, if your last name begins with the letters A thru I, bring a salad, letters J thru Q, bring a hot dish, and letters R thru Z bring a dessert. Please bring your own drinks and settings. The Board of Directors will provide the charcoal. This will be our last chance of the summer to meet our new residents and visit with our old friends. Caretaker's Corner

Mike has been very busy this month including the installation of a new water line on David and the repair of several water service valves. Mike investigated and prepared a report with options for connecting water service to two new construction sites that at the present time have no water supply at all. He also began the process of labeling and recording the location and purpose of all water valves in the Park. He helped Aqua Labs perform the annual and five year testing of wells. He also scheduled the garbage pick-up and continued with the watering of the apple orchard. Mike has started preliminary work on the installation of an outdoor light for both the sand shed and garbage dumpster area. Mike has finished the repair of the Lodge floor next to both the front and rear doors. The picnic tables have been cleaned, sanded, and stained and again, if you have not inspected the new horseshoe pit, you need to check this out! Not only is the horseshoe pit greatly improved, Mike installed a safety barrier and a viewing bench. (The only thing we need now is an ice cooler!!!) By the way, the total cost of this project was \$24.00; thanks to Mike's ability to scavenge materials. Great job Mike and thanks for the dedication and hard work you give to our Park.

### **Board of Director's Meeting August 22, 2004**

Present were: President Michael Rainwater, Vice President Bob Cloak, and Treasurer Roger Townsend, Members: Charles Aston, Tom Clark, and Robert Snell. Absent and excused members: Secretary Norrine Coyle, Greg Brown, and Sean Kasper.

The meeting was called to order by President Michael Rainwater at 8:30 A.M.

Members before the board: Mike Van Gundy and Eric Canales. Mr. Canales asked if the Board would accept some playground equipment as a donation to the park. Mr. Canales presented the Board with a picture of the equipment and the Board told Mr. Canales that we would be very happy to accept his donation.

Correspondence: Letter from Gorden & Lorraine Nicholson donating \$25.00 (tagged fish) towards next years' fishing derby. Letter informing the Board of a large hornet nest located on Goliath. Letter from the Rural Water Association asking for renewal of membership. Letter from SBC indicating that we need to renew our contract concerning the pay phone outside the Lodge. Letters written by President Rainwater to Tuolumne County Building Dept. concerning water connection and Dish Network concerning installation of a Dish satellite. Received a letter from Mr. Davis approving the cost of \$1,000 for an audit of last year's financial activities.

#### Committee Reports:

Water – Bob Cloak – Water used during the past month was 1.67 million gallons. Due to two new construction sites, it will be necessary to attach into our 4 inch water main at one site and a 2 inch cabin line on the other site. Both lots are without water at the present.

Roads – Robert Snell – The cold patch needed to repair several areas within the Park should be purchased from Simunaci when they come to work on the 4 inch water main on Esther. Simunaci would have this material available at a reasonable cost and save the Park the cost of delivering this material.

Buildings – Tom Clark – The phone booth outside the lodge has been disconnected and Tom would call SBC and have it reconnected. The windows in the lodge need washing and it was discussed as to who is responsible for cleaning the inside of the Lodge. All parties that use the lodge would be contacted and asked to help maintain the inside of the Lodge after their use. An estimate for signs and the purchase of these signs was tabled until Sept. in order that Robert Snell checks on other estimates. The old snack building located in the picnic area has a large number of bikes stored inside and by motion (Clark/Snell, unan.) that these be removed and donated to a local charity. Tom indicated that there are several dead trees in the park and Mark would be in next week to give us an estimate on the removal of these trees. Tom informed the Board that the Lodge capacity is 120 people.

Timber – Roger Townsend – Contract has been signed for the timber harvest and the cutters will be in on Monday, August 23, 2004 to start the timber harvest.

Health & Safety – Sean Kasper – President Rainwater reported that the lake has been closed due to the water becoming stagnated. The Board agreed that Labor Day weekend will be the last chance for anyone, with a license, to fish the lake. Individuals under the age of 16 are allowed to fish without a license. On Tuesday, September  $7^{th}$ , the lake will be drained.

Equipment - Greg Brown - Tractor will be picked up for a scheduled maintenance.

Recreation - Chuck Aston - Charcoal and lighter fluid has been purchased for the Labor Day Weekend.

Finance – Roger Townsend – During the past month, a total of \$56,107.45 has been deposited from assessments, gate income, and payment from a contractor due to damages caused by said contractor. There are 18 lots past due on their assessment totalling \$10,485.42. The bills for

the month totaled \$34,881.23. \$20,000.00 was owed to Roger Brown, Park attorney, and President Rainwater was going to contact Mr. Brown concerning this bill and ascertain what the insurance company has paid to Mr. Brown in addition to what the Park has already paid.

Old Business: President Rainwater reported to the Board that a new workmen's compensation policy had been approved by the Board via telephone contact and would save the Park \$1,500 a year in premiums. The company is Zenith and was recommended by our insurance company. Tom Clark indicated that it would take approximately 300 feet of wire to install a light at the sand shed and he would get a cost regarding this project. An update regarding the new water line on Wheeler and David was presented to the Board and the completion has resulted in all homeowners having the proper water boxes in front of their residences on Park property.

New Business: A job description concerning the caretaker's position was presented to the Board by President Rainwater and the Board members were asked to review this description, and at the next Board meeting, a discussion would be held concerning this information. A reminder for the Labor Day Weekend activities was announced and it was suggested that we might have a horseshoe tournament on Sunday. A motion was made and passed unan. to approve a pay increase for Mike Caropreso. In addition, a second motion was made and passed unan. to provide medical insurance for Mike Caropreso and his wife. The policy for medical insurance and deductible payments will cost the Park an additional \$32.00 more than what we previously paid for medical coverage per year.

Other: Tom Clark announced that he has a new e-mail address: clarkscabin@earthlink.net and new fax number: 586-3001.

There being no further business, the meeting was adjourned at 10:20 A.M. The next meeting will be held on September 18, 2004, at 8:30 A.M. Respectfully submitted,
