FALL - ONE OF THE QUIET PEACEFUL SEASONS

Gone is the rush and noise of summer. The mornings are cold, but the days are pleasant and warm. The best time time to visit the back country is now, only be sure to keep a wary eye on the weather reports. Be sure not to venture too far without adequate fuel, tires, etc. A rather new paved road we explored lately that warrants your try is the Cottonwood Road. It starts at Tuolumne City and goes all the way to Cherry Lake on the edge of Yosemite Park. It crosses areas which until now were only seen by 4-wheelers. You can continue from Cherry to Highway 120 and back by Groveland, Priest Grade, and back to Sonota. Good motoring! P.S. The Cottonwood Road is new enough not to be on even the latest road maps.

AN HISTORICAL NOTE

For the benefit of those members who enjoy an occasional historical bit we are including this excerpt from "The California Gold Rush".

"As camps became a bit more settled, the miners recognized that they needed some kind of regular court. At first, many of them followed the Mexican system and elected alcaldes, whose duties combined those of mayor and justice of the peace. In 1850 the legislature of the new state of California abolished the office of alcalde and required towns to have justices of the peace instead. But for the mining camps, where things were conducted in informal fashion, it was a change in name only.

Very few of these local magistrates had amy experience in the law. Most of them were simply honest men doing their best to be fair and to conduct their courts with something resembling correct legal procedure. But at times some of the homespun judges made strange decisions. The miners of Sonoma elected an alcalde mamed Sullivan, whose very first case involved a Mexican, Juan Santa Ana, who had been arrested on the complaint of one William Smith who accused him of stealing a pair of leather leggings. Sullivan heard the sentence, found Santa Ana guilty, and fined him three ounces of gold. Then, to make sure he had not overlooked anything, he turned to Smith and fined him one ounce of gold for having

made the complaint.

But this was nothing compared to the highhanded way in which Major R.C. Barry made his decisions in Sonora, where he ruled as justice of the peace. Fortunately, he kept a record, and the grammar and spelling were as weird as some of the decisions he describes. One example will show Justice Barry at his best:

"No. 576. This is a suite for Mule Steeling in which Jesus Ramirez is indited fur steeling one black mare Mule, branded 0 with a 5 in it from sheriff Work. George swares the Mule in question is hisn and I believe so. On hearing the case I found Jesus Ramirez of feloaniously and against the law made and privided and the dignity of the people of Sonora steeling the aforesade mare Mule sentensed him to pay the Cost of Coort 10 dolars, and fine him a 100 dolars more as a terrour to all evil dooers."

So far so good. Major Barry seems to have made a fair decision, and the punishment he ordered appears mild enough. But what happened next did not even faintly resemble either law or equity:

"Jesus Ramirez not having any munney to pay with I rooled that George Work shuld pay the Costs of Coort, as well as the fine, an in defait of payment that the said one mare Mule be sold by the Constable John Luney or other officer of the Coort to meet the expenses of the Costs of Coort as also the payment of the fine aforesade. R.C. Barry, Justice Peace. John Luney, Constable."

In many of his cases, Barry seemed more interested in collecting the fines and especially his own costs of court than he did in dispensing justice. But in this particular case Sheriff Work had a lawyer who protested Barry's ruling. Barry concludes the case with this note:

"H.P. Barber, the lawyer for George Work in solently tole me there was no law for me to rool so I told him that I did not give a damn for his book law, that I was the Law myself. He jawed back so I told him to shetup but he would not so I fined him 50 dolars and comited him to gaol fur five days fur contempt of Coort in bringing my roolings and disissions into disreputableness and as a warning to unrooly citizens not to contredict this Coort."

ROADS - Johnson - Part of patch work has been done on roads. Contractor coming in today to go over balance of work required. Abraham is ready for rock as soon as one culvert is moved.

WATER - Bell - Water rank crew arrived on 9/6/75. Will start construction on 9/8/75. Dean reported that Labor Day the West side of Park ran out of water new looping system will eliminate this type of problem.

EQUIPMENT - TD18 has been repaired and is useable again. Rhino blade installed on Loader and does a good job.

RECREATION - Harmer - Bar B Q was well attended. Sand placed by swings and slide. Refreshment stand closed for the winter. 361 adults, 60 children. Total income \$1274.00, expense \$532.67, net profit \$743.50 plus \$75.75 from refreshment, Bingo, & Juke Box. Rec Committee now has a total of \$983.13 available. REAL ESTATE - Wallis - Discussed Boy Scout and discrepancy and awaiting response from them.

Motion by Dean, second by Stephenson, we reopen Nichols Spring Road as soon as construction completed and close temporary rear access to Nichols Spring area. Yes, 2 no. Motion carried.

Received notification of 2 recent lot sales, both purchasers members of the order.

BIDGS - Dean - Suggested construction of storage area in Recreation Hall for Juke Box and new chairs. Hels in abyeance.

ELALTH & SAFETY - Breen Hildebrand - no report.

FINANCE - Motion by Harmer, sec by Dean pay bills amounting to \$2163.79. Balance in ckg 8/31/75 \$2697.95 - plus deposits of \$4217.57 - total \$6915.52 - less cks of \$2163.79. Bal in ckg \$4751.73. Savings bal \$49246.71 plus equip reserve of \$6610.00 - accts rec \$27893.18.
