

Board of Directors Meeting September 18, 2004

Attendance: President Michael Rainwater, Vice-President Robert Cloak, Secretary Norrine Coyle, Treasurer Roger Townsend, Members Present: Chuck Aston, Sean Kasper, Members Absent Excused: Tom Clark and Robert Snell, Members Absent Unexcused: Roger Brown

The Board of Directors meeting was called to order by President Michael Rainwater at 8:30A.M.

Members before the Board: pat Monahan and Doris Selman. It was mentioned that Hwy 108 Fire Safety Council Communities have to have a wild fire plan in order to qualify for grants. Mrs. Monahan attends the meetings representing the Cow Creek area. We need to have someone representing the Park. It was decided that Mrs. Monahan would also represent the Park. If she is unable to attend, one of the following would represent the Park: Roger Townsend, Sean Kasper, and if he agrees, Mike VanGundy.

Correspondence: Letter to Louis & Helen Fortman re. 25497 Rebekah parking pad; copies of 2 letters from Roger Brown to C.N.A. Insurance Co. in New York City; Letter to Carolyn Mann for permit for electricity at 25144 Deborah; application to Blue Shield on 9-1-04 for medical insurance for the caretaker; survey from Scottsdale Indemnity Co., notice of water quality conferences by Hach and Rural Community Assistance Corp.; card from SBC re. Long distance calls rate increase; and a change of address for California Rural Water Assn.

Committee Reports:

Water – Cloak: Water used during the past month was 1.3 million gallons. He is continuing to work on getting water to lots on Rebekah and Esther. When Simunacci comes in to do the work, the water will be off in that area for 24 hours. Condor did an estimate of the cost of putting a water line to the main tank several years ago however; in the mean time, engineers who design water systems all have said it is not needed. The pumps will be operated at night, and if chlorination is necessary, it will be done at night.

Roads – Snell: President Rainwater said we have learned that it will be cheaper to get a load of cold asphalt materials ourselves rather than have Simunacci bring it up when he does the water line repairs.

Buildings – Clark: President Rainwater said Tom is working on getting the wire to the sand shed so we can install a light in that area.

Timber – Townsend: Timber cutting by the water tank and David is finished. They also logged some more near Three Links Camp to extend the fire break and complete the 200,000 board feet needed to fulfill our minimum requirement of board feet. The grinder is going to be brought up to clean up the areas where logging has been done. The estimate of 200,000 board feet of

lumber was met. Some trees along Wheeler have been cut but we do not know who cut them. (It was determined that PG&E had requested those trees be cut.)

Health & Safety – Kasper: Sean thanked people for slowing down. Watch out for kids walking down the road from where the school bus lets them off at the Highway and Wheeler Road. The lake is closed but has not been drained in case the water is needed for fighting fires. It may be too shallow for helicopters to use. Sean will determine the best way and best price to clean the silt from the lake once it is drained. He will also get information about propane and diesel generators.

Equipment – Brown: President Rainwater said the tractor has been serviced. The master cylinders were leaking and had to be rebuilt.

Recreation – Aston: The Labor Day functions went well. About 70-80 people attended the potluck. The Bingo games raised \$400.00 for the fishing derby. Rolls of table cloth were left over that can be used for future dinners. The next function is the holiday dinner. By motion (Aston/Kasper, unan.) it was agreed to change the date of the December Board Meeting to December 11, which is the date of the holiday dinner.

Finance – Townsend: Since the last meeting, assessments in the amount of \$4,445 have been paid plus \$49.08 for late charges. Income received: water reserve, \$180; pine needles, \$180; Bingo, \$400 for the fish derby; Federal tax refund, \$5,200; utilities, \$37.55. Bills totaled \$10,876.30. By motion (Kasper/Cloak, unan.) the bills were approved for payment. The list of homeowners who have not paid their assessments was provided to President Rainwater.

Old Business:

Doris Selman said some of the women who live in the Park have been cleaning the hall for the last 3 years. She wondered if that should be the caretaker's job. The President fined some people for dumping inappropriate materials in the dumpster. Roger Brown, the Park's Attorney, sent a bill for the Boy Scout litigation for \$63,388.16, of which C.N.A. will pay \$47,607.91, leaving a balance of \$15,780.25 for the Park's portion of the bill. Pat Monahan said they have sprayed the hornet nests at their place. The pay phone has been repaired. There are five dead trees in the Park which will cost about \$450.00 to remove. Board unan. approved to have Mark remove the trees. The new Job Description for the Park Caretaker was discussed. By motion (Kasper/Aston, unan.) it was approved, but may need to be amended depending on requirements of Blue Cross Insurance.

New Business:

President Rainwater asked that each Board member make a list of the duties he or she feels the committee they head should perform and turn them in next Board meeting.

There being no further business, the meeting adjourned at 11:05a.m. The next meeting will be on October 16, 2004, at 8:30 a.m.

appreciate more volunteers for this year's fishing derby. Mike Ford said he would donate two \$50.00 Kids R Us gift certificates for prizes. (At the Board Meeting after the annual meeting, Michael Rainwater said he would also donate two \$50.00 gift certificates from Kids R Us) Four fish will be specially marked. Kids catching those fish will receive the gift certificates.

Timber – Coleman: The President reported on the timber plans to harvest approximately 210,000 board feet. Some trees are dangerous and will be taken out. In the last 10 years, we have harvested 2.6 million board feet, and have increased the amount of our timber by over 800,000 board feet and have cleared over \$500,000. By motion, (Daryl Clark/Elsie Manning, unan.) the area from the bridge to the end of Jordan will be taken out of the logging program. After a discussion about burning the meadow to get rid of the weeds, there was a motion (Bob Hintz/Dorothy Goff, carried) not to burn the meadow. There was a discussion about cleaning the willows from the creek. It would cost \$6,200 to cut the willows to keep them from choking the creek plus some amount for the chemicals that would be used to keep the willows from growing back. By motion (Ron Hawke/Elsie Manning, carried) it was agreed that if the Board determines there is a problem, the Board is authorized to proceed with the cleaning and treatment of the willows. There was a discussion of getting the silt out of the lake to maintain the lake. Fred said that at the annual meeting in 2005, the group needs to vote on whether or not to continue the work in the forest. He mentioned that all burn permits have been cancelled as of May 10. The Board needs to look into some way to clean out all of the bear clover in the Park. He thought the Board should consider giving gift certificates to Steven Wallace, Paul Wallace, Daryl Clark, Larry Vaughn, Arlen Santos, Mike Rainey, and our employees who fought the fire until C.D. F. fire crew arrived. He said he has allowed people from the outside to bring slash in to help increase the number of tons of material resulting from the grinding process. A motion that we do not assess property owners for the grinding program died for lack of a second. By motion (Charles Aston/Elsie Manning, unan.) any money that is not used this year, or any profit from the sale of the grinding materials will be saved for the grinding process next year.

Finance – Bonner: Budget has been raised because of increases in various things – gas, garbage, insurance, and workers' comp., an increase for the employees, and the grinder. We had to borrow \$28,000 from the Timber Fund to pay for our insurance. This will be replaced when we get a refund from the insurance company. We had to \$6,000 for a six year audit. It may be necessary to hire someone to do the bookkeeping work. By motion (Bob Hintz/Daryl Clark, carried) the budget was approved.

Buildings – Smith: The report was read by the Secretary. The main work done was moving the office upstairs in the hall. The park phone and fax are located in the office. The last new window was installed in the hall. Also, Roger Townsend installed a new sink in the kitchen.

Old Business: Out of the two law suits that were pending at the beginning of the 2004-04 fiscal year, one was settled out of court. Regarding the Boy Scout property, which is going to court, Roger Brown, the Park's attorney, will be handling the case. The Boy Scouts want to use Jordan Road, which the Park is maintaining and plowing. They do have other access to their property on a County road. To continue crossing the creek, they would have to build a bridge which would be on our property. The President has heard the Boy Scouts want to sell their property to someone who wants to set up a "Wayward Youth" camp. Court is scheduled for June 7. Also, we need to upgrade the water system with a direct line to the tank.

New Business: An audit should be done because both the President and the Treasurer are going off the Board. Mike Rainey will take care of the gate. It was mentioned that the bylaws should be restructured so there is no difference in who can vote. By motion (Pat Monahan/Ron Hawke, unan.) it was requested that the Park rules be sent out once a year with the assessment bills. A question was asked about stacking some building materials and who will clean up after the building is done. The contractor is responsible. In a discussion it was mentioned that if we have only two employees, neither employee can be the "boss." There has to be at least three employees with one of the three being the "boss."

Election: The three Board positions open this year are Richard Bonner, Fred Coleman, and Norrine Coyle. The election board appointed was Barbara Adams, Cindy Kasper, and Elsie Manning. Dorothy Goff nominated Michael Rainwater; Daryl Clark nominated Bob Cloak; Ed Cole nominated Charles Aston; and Roger Townsend nominated

Odd Fellows Sierra Recreation Association Annual Meeting Minutes – May 30, 2004

The Board is extremely sorry for this document being so late but due to circumstances beyond anyone's control this is the earliest that we were able publish this information.

The meeting was called to order at 9:00A.M. by President Fred Coleman.

Board Members Present: President Fred Coleman, Vice President Robert Snell, Secretary Norrine Coyle, Treasurer Richard Bonner, Member Roger Townsend; absent and excused Greg Brown, Sean Kasper.

There were 61 Odd Fellows and Rebekahs and a total of 83 in attendance which exceeded the amount needed for a quorum.

The pledge to the flag was led by Tom Clark. The invocation was given by Richard Wheeler.

By motion (Elsie Manning/Bob Hintz, unan.) the minutes of last year's meeting were approved as mailed.

Correspondence: None

Announcements: The President announced that Gary Scarborough was terminated on Thursday, May 27, 2004. He also mentioned that mountain lions and rattlesnakes have been seen in our area. The needle pick up is going well. Next Sunday will be the last day to put needles out for pick up. It costs \$2,000 to bring Grover's grinder up the hill. We will be sharing the cost with three other areas.

Committee Reports:

Water – Selman: The report was read by the Secretary. Water consumption for the year was 11,737,700 gallons. The samples of our water have been clean and pure. The President said he had found several people who have water licenses as a back up. There was one water break on Abraham. There was a discussion about a generator to pump water in cases of emergencies. Richard Bonner said there is plenty of money in the Equipment Reserve to purchase a generator. We also need to put in a chlorinator. We must keep up our water system or the State will take it over.

Equipment – Brown: The President said there are no big issues on equipment. We are looking at 2 to 4 tires on the snow plow.

Roads – Snell: He said we have been trying to keep up the roads in the park using part of the timber funds. There will not be any work done on roads this year because of the lack of funds.

Health & Safety – Kasper: The President read Sean's report. He's asking people to slow down. The level of the lake is extremely low already this year. Samples of the water are being taken to be sure it is still safe. Dogs are not allowed in or near the lake because of the danger of contamination. Watch out for rattlesnakes.

Recreation – Townsend: Roger thanked Darlene Helmer, Norrine Coyle, and Ruth Townsend for the cookies for the meeting. The report on last year's fishing derby indicated 92 registered, 113 fish caught. There was about \$2,400 in donations. This year's fishing derby will be on June 19 at 8:30 with lunch at 12:00. We had the Christmas dinner and St. Patrick's dinner and both were successful. He thanked all who donated prizes for the fishing derby. He would

appreciate more volunteers for this year's fishing derby. Mike Ford said he would donate two \$50.00 Kids R Us gift certificates for prizes. (At the Board Meeting after the annual meeting, Michael Rainwater said he would also donate two \$50.00 gift certificates from Kids R Us) Four fish will be specially marked. Kids catching those fish will receive the gift certificates.

Timber – Coleman: The President reported on the timber plans to harvest approximately 210,000 board feet. Some trees are dangerous and will be taken out. In the last 10 years, we have harvested 2.6 million board feet, and have increased the amount of our timber by over 800,000 board feet and have cleared over \$500,000. By motion, (Daryl Clark/Elsie Manning, unan.) the area from the bridge to the end of Jordan will be taken out of the logging program. After a discussion about burning the meadow to get rid of the weeds, there was a motion (Bob Hintz/Dorothy Goff, carried) not to burn the meadow. There was a discussion about cleaning the willows from the creek. It would cost \$6,200 to cut the willows to keep them from choking the creek plus some amount for the chemicals that would be used to keep the willows from growing back. By motion (Ron Hawke/Elsie Manning, carried) it was agreed that if the Board determines there is a problem, the Board is authorized to proceed with the cleaning and treatment of the willows. There was a discussion of getting the silt out of the lake to maintain the lake. Fred said that at the annual meeting in 2005, the group needs to vote on whether or not to continue the work in the forest. He mentioned that all burn permits have been cancelled as of May 10. The Board needs to look into some way to clean out all of the bear clover in the Park. He thought the Board should consider giving gift certificates to Steven Wallace, Paul Wallace, Daryl Clark, Larry Vaughn, Arlen Santos, Mike Rainey, and our employees who fought the fire until C.D. Tom Clark. Pat Monahan asked that the votes be cumulated. (On his proxy, Ed Smith had also requested that votes be cumulated.)
