- □ Members before the board: Leo Amaro with a personal matter before the board. {Motion to allow Leo who has a mobility disability to have access to back roads for deer season. Motion by Sue Collie,2<sup>nd</sup> by Clark Kellog; vote: yes 5, no 1.}

**Correspondence:** 1) Kirk Kleinen letter; motion to accept his agreement by Clark Kellogg, 2<sup>nd</sup> by Mike Ford. Equipment: Orth- Alan was absent. It was noted that the steel has been delivered.

**<u>Timber:</u>** Varvayanis- The harvest has been delayed until October.

Health and Safety: Selman- Doris was absent. Board discussed Mark Mena's concern on Esther.

Recreation: Clark- Tom was absent. Next dinner is Christmas Dec. 15<sup>th</sup>.

Finance: Clark-Tom was absent and his wife, Linda presented for him. Total expenses- \$5668.29 (not
