#### ITEM DESCRIPTION

1. Remove and dispose off-site waste side materials.
2. Seal slope to undisturbed native material.
3. Furnish and install 4" perforated drain system as shown in drawing prepared by O'Connor Engineers, Inc.
4. Place first layer of Mirafi 140 fabric against native slope.
5. Import and place 8" minus crushed rock to restore slope back to a 1-1/2 to 3 slope.
6. Place second layer of Mirafi 140 fabric over new slope.
7. Cover slope with approx. 8" thick soil top dressing and reseed.
8. Remove section of failed asphalt and repave asphalt plug.
9. Overlay section of Esplanade Ave. approx. 50 ft in length.
