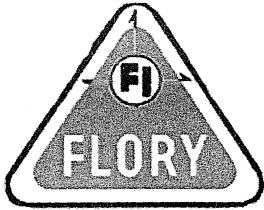



Subject: My Resignation

I am hereby notifying you of my resignation as a Director of the OFSHA Board.

The results of OFSHA's attorney's interruption of the recall criteria in the by-laws and a subsequent 'loop-hole' was that if a Director received 17 or more 'Do Not Recall' votes that Director would not be recalled regardless of the number of received 'Do Recall' votes.

The homeowners voted by a wide margin to recall all the OFSHA Directors (see below for vote results). It is clear that in light of the homeowners strong 'no confidence vote' that to continue as an OFSHA Director would be an indication of serving self and not the homeowner's interests. Therefore, I am acceding to the homeowner's wishes and resigning as a Director of the OFSHA effectively immediately.
