**DEFENDANT ODD FELLOWS SIERRA RECREATION ASSOCIATION'S
STATUS STATEMENT**

Pursuant to the Administrative Law Judge's January 10, 2017 Email Ruling requesting status of Tuolumne County Superior Court, Case No. SC19463 from ALJ Eric Wildgrube of the California Public Utilities Commission ("Commission"), Defendant Odd Fellows Sierra Recreation Association, a California corporation ("Odd Fellows"), files this Status Statement in connection with the complaint filed by Complainant Charles Paul Varvayanis ("Complainant") in Tuolumne County Superior Court, Case No. SC19463:

1. On October 7, 2016, Complainant filed a complaint against Odd Fellows in Tuolumne County Superior Court, Case No. SC19463. The Tuolumne County Superior Court complaint was filed after the complaint filed by Complainant with the Commission in this matter. In the Tuolumne County Superior Court complaint, Complainant alleges that he is owed \$81.78 because he claims that "CPUC Decision 16-01-047 dated January 28, 2016 orders 20 payments of \$15.57 totaling ~\$311.33 per lot. I have two lots. The Defendant has paid me 2 x \$2.88 (3/25/2016) 2x \$0.00 (6/24/2016) and 2 x \$2.88 (9/25/2016)." The total amount claimed by Complainant in Case No. SC19463 is **\$81.78**. This is identical to the amount sought by Complainant in this matter.

2. This matter was set for trial on January 6, 2017.

3. On January 6, 2017, Odd Fellows and Complainant mediated SC19463 and entered into a written Settlement Agreement pursuant to which they "agree[d] to postpone today's

(sic) trial and both agree to await the California PUC decision.” Complainant has not been awarded \$81.78 in SC19463.
