18 **REPLY TO DEFENDANT ODD FELLOWS SIERRA RECREATION ASSOCIATION'S**

19 **FURTHER RESPONSE TO EMAIL RULING RE EVIDENCE**

20 Pursuant to the E-mail Ruling of Administrative Law Judge Eric Wildgrube dated
21 January 12, 2012 Complainant Charles Paul Varvayanis (hereafter "Complainant"), files his
22 reply to Defendant Odd Fellows Sierra Recreation Association's Further Response to Email
23 Ruling RE Evidence as follows:

24 **LATE FILING**

25 Due to extreme weather including both snow and wind, the Complainant experienced
serious problems transferring files across the Internet all day on January 20, 2017 and suffered
complete loss of Internet connectivity on January 20, 2017 at 6:51 PM followed by loss of

1 electric power, loss of telephone service and loss of cell phone service. It was not safe to travel
2 to town but the Complainant did so once only on January 25, 2017 to transport the park's
3 caretaker to the emergency room in Sonora, CA due to a head injury. During that trip, the
4 Complainant attempted to contact the CPUC but found his cell phone inoperative due to a
5 firmware update failure caused by loss of signal during the update process. The Complainant
6 systems came back on-line on January 26, 2017 at about 5:30 PM. Soon after that, the
7 Complainant received the Defendant Odd Fellows Sierra Recreation Association's Response to
8 Email Ruling RE Evidence, dated January 20, 2017 and Defendant Odd Fellows Sierra
9 Recreation Association's Further Response to Email Ruling RE Evidence dated January 25,
10 2017. The Complainant filed and served the required documents on January 26, 2017 and
11 January 27, 2017, as soon as possible upon the Complainant's systems coming back on-line.
12 Because of the above, both of the two required filings were filled late and **the Complainant**
13 **requests the Commission accept those filings and adjust the schedule if the Commission**
14 **deems it necessary to adjust.**

15 Attached is an e-mail sent by Sierra Park Services, Inc. last night January 26, 2017 at
16 10:50 PM partially documenting the situation in the subdivision the Complainant resides
17 (Exhibit: Current Conditions in the Park). Sierra Park Services, Inc. was spun off by
18 Defendant's Odd Fellows Sierra Recreation Association, Inc. at the same time Sierra Park Water
19 Company, Inc. was spun off in 2013.

21 **REQUEST TO REJECT ODD FELLOWS SIERRA RECREATION ASSOCIATION'S**
22 **FURTHER RESPONSE TO EMAIL RULING RE EVIDENCE**

23 Because the situation above was the result a natural disaster beyond the control of the
24 Complainant and because Gov. Jerry Brown has declared a state of emergency across California
25 due to recent damaging storms, the Complainant respectfully requests "Odd Fellows Sierra

2 otherwise denied or squashed.
