RULING RECEIVING EVIDENCE

On January 12, 2017, the Assigned Administrative Law Judge issued a ruling identifying evidence and requiring the parties file additional evidence, objections and stipulations to evidence, and information concerning witnesses and testimony.

Defendant Odd Fellows Sierra Recreation Association (Odd Fellows) filed its responses on January 20, 2017 and January 25, 2017. Although Complainant Charles Paul Varvayanis (Varvayanis) filed his Opposition to Motion to Dismiss on January 20, 2017, he did not file any response to the January 12, 2017 ruling until January 27, 2017 and January 30, 2017.

Based on the filings and record herein and the motions and stipulations of the parties, the following is admitted into evidence:

The late filed objections of Varvayanis to OF-1 – OF-8 are overruled. The objections were made on the grounds Varvayanis did not know of the existence of these documents until January 5, 2017 and the numbers of these documents are not in sequence. These objections are understood to be objections to the authenticity of the documents. Varvayanis' lack of knowledge concerning the existence of documents is not a valid basis for an objection. The authenticity of these credit memos and invoices is established moreover, by Varvayanis' own proffered evidence: CV-1 – CV-4, the initial June 6, 2012 invoices; CV-5 and CV-6 reflecting two payments in the amount of \$571.60 each, which is the amount stated by each of the December 12, 2012 invoices, OF-5 – OF-8; CV-7 and CV-8 reflecting two payments in the amount of \$452.40 each, which was the amount remaining owing on each account after the application of the credit memos (OF-1 – OF-4) to the initial invoices (CV-1 – CV-4). Additionally, Varvayanis exhibit CV-12 states he paid \$571.60 for water service for 2012-2013 and

Varvayanis' Opposition to the Motion to Dismiss, filed January 20, 2017, states he was informed on behalf of Odd Fellows in early 2013, at the time he made the relevant payments, that he owed amounts consistent with these invoices and credit memos.¹ Therefore, the late filed objections of Varvayanis to OF-1 – OF-8 are overruled and the documents are admitted into evidence.

Judicial Notice

The late filed objections of Varvayanis to ALJ-1 are similarly without merit. Official notice of the foregoing report is proper pursuant to Evidence Code section 452(h). Official notice is taken to establish Odd Fellows stated a budgeted expense of \$571.60 per lot for water service for fiscal year 2012. It is noted, although Varvayanis objects to ALJ-1 being used to establish Odd Fellows stated a budgeted expense of \$571.60 per lot for water service for fiscal year 2012 his objection goes to the accuracy of the number (did water service cost \$571.60?) and is not an objection that Odd Fellows did not state in the December 7, 2012 report that the budgeted expense for water service for fiscal year 2012 was \$571.60 per lot. Furthermore, Varvayanis acknowledges the existence of this document in his Motion to Dismiss.²
